# **Policy Statement:**

# 1. Purpose:

- Hand-held metal scanners may be used by authorised personnel for the purpose
  of detecting prohibited items that pose a threat to the safety and security of the
  school community.
- They may also be used prior to practice or public examinations to ensure that there are no mobile phones or other prohibited electric items (e.g. smart watches) which could lead to accusations of malpractice.

#### 2. Authorised Personnel:

Only designated staff members trained in the proper use of hand-held metal scanners are permitted to conduct student searches.

• The Headteacher or Designated Safeguarding Lead will oversee the training process for staff members authorised to use metal scanners.

# 3. Scope of Searches:

- Student searches using hand-held metal scanners will be conducted in accordance with reasonable suspicion and established protocols.
- Searches will be conducted in a manner that respects the privacy and dignity of the students involved.

## 4. Notification and Consent:

• Prior to conducting metal scanner searches, students and parents/guardians will be informed of the school's policy regarding the use of metal scanners.

- Vapes
- Lighters
- Bladed objects
- Mobile phones / Smart watches or other devices in practice and public examinations
